

Any cases which have been resolved must submit the appropriate orders by noon on March 3, 2026. Counsel are reminded of their obligation under O.C.G.A. § 9-11-58 (b) to file the case disposition form. Any proposed order of continuance must be submitted to the Court by noon on March 3, 2026.

All cases still pending upon completion of the non-jury calendar, which are not already assigned to a judge, will be randomly assigned by the Clerk, pursuant to the procedures set forth in the case assignment order.
